#### **PURPOSE:**

To seek the Board's approval for the sale/transport of water to the City of Red Deer within the corporate boundaries of the City of Red Deer

#### **BACKGROUND:**

The discussions to supply property owners in the City of Red Deer via the regional water line began in 2013 when a major industrial business directly solicited the regional water commission. The Commission at that time directed the property owner back to the City of Red Deer and passed the following conditions for negotiating:

- 1. The Commission will only enter into a water supply agreement with the City of Red Deer, who would then bill property owners. This practice is consistent with all other supply agreements the Commission has currently entered into.
- 2. The City of Red Deer would have to agree that the water supplied to the property owners via the Commission's regional line would not be applied against the Commission's current or future water allotment from the City.
- 3. The City would be responsible for all engineering and construction costs including the Commission's administration, legal and engineering review costs.
- 4. The current proposal is to supply the manufacturing process. Given the size and location of the facility, any estimate should include supply for fire suppression. An engineer's estimate of average and maximum daily usage would need to be provided by property owners.
- 5. The Commission would charge a rate higher than its current whole sale rate back to the City. The Commissions existing rate to its member customers is subsidized by fixed administration fees paid by the two County members. A blended average of the rates charged by the three urban municipalities would be a possible starting point.
- 6. There would be no further considerations to providing water service to other customers in the area.

The City formally requested that the Commission supply the City of Red Deer in December of 2014 along with a request to purchase the line itself from Highway 11A to the City's corporate boundaries.

In July of 2015, The City requested that the Commission consider an extension of service to include supplying the hamlet of Central which was annexed by the City and has had water supply issues. The Commission Board approved the change in August 2015. At that time the Commission outlined the process necessary for the Commission to consider the request.

At its regular meeting on August 15, 2016, Red Deer City Council passed a resolution to send a request to the Commission to consider providing water delivery service to properties within the City of Red Deer.

#### **ISSUE ANALYSIS:**

The request from the City is the first step necessary for the delivery of water service. The next step is for the Commission to agree in principle. If both parties agree, then Administration would forward an agreement to the City. An executed agreement and copies of the resolutions from both the City and Commission would then be forwarded to Minister of Municipal Affairs who has final authority to approve the decision.

Administration has drafted an agreement based on the Commission's standard supply agreement. The City has pointed out that the original agreement between the City of Red Deer and the Commission, dated October 4, 2014, outlines the methodology for pricing of water supplied. Administration had initially proposed a rate based on the Commission model. That model is a cash-based model and not the utility rate model. The proposed agreement drafted by Administration has been updated to reflect the pricing terms outlined in the original agreement from 2004. However, volumes would not be counted against the Commissions allocation under the 2004 agreement.

Administration has also prepared a draft utility rate which will be shared in camera.

The agreement would end on the earlier date of:

- 1. The portion of the regional line in the City is sold to the City or
- 2. The expiration of the 2004 water supply agreement between the City and Commission.

#### FINANCIAL IMPLICATIONS:

The sale of water to the City will have a minimal impact on the Commission in the short term as the amount of water to be sold is approximately 20,000 m3 per year. However, should the demand for water grow or the City desires to expand service beyond the current service area, then the issue of selling the line will become a bigger financial consideration.
