- Water sales are not quite at the three years average but higher at this point in time compared to last year; should be back on target if water demand remains healthy.
- 2012 budgeting should begin shortly; would like to complete five year projections.
- Administration has yet to receive 2010 reconciliation and true up numbers from the City of Red Deer.

 City of Red Deer has contact NRDRWSC with regards to our stance on the fluoridation issue.

Operator's Report

Mr. Goudy discussed recent activities as per the attached Operational Report herein.

In summary:

- Note the error in the amount of AB One Call locate requests in the report listed at 162, should be 506 responses (3/4 of which were for the Blackfalds area).
- Reset modem at Pumphouse A, Lacombe AB.
- Ordering in parts for upcoming valve repair/replacement program in 2012.
- A major commercial development is planned for the City of Lacombe; an area that is situated directly over the water line; the City will observe closely this development and the continued safety of the water line.

Financial Report

Mr. Minchin presented the Financial Statements as of July 31, 2011.

In summary:

- Water sales are not quite there but are progressing positively.
- Transfers to be decided at year end.
- Financials are fairly stable with no surprises as of yet.
- Operations are still below budget.
