Mayor Creasey disclosed that his wife is employed with BDO, the Commission's Auditors, and going forward she will not be working on the Commission's file. Mr. Minchin advised Mayor Creasey that there is a working agreement with BDO to ensure that there is no conflict with the file.

Mayor Creasey inquired about why the there is only a three (3) years service contact between the City and the Commission. Mr. Minchin explained that with the Wastewater Commission starting they want to allow for some discretion between the two Commissions.

Operations Report

Mr. Huston discussed the recent operation activities.

In summary:

- The Alberta One-Call locate requests for October are on par with last year.
- The Operator and Endress & Hauser performed water meter verification testing on all meters with the expectation of 39th Ave and the Main Vault. All of the meters tested came back within AWWA requirements. The 39th Ave and the Main Vault will be tested in 2018.
- Stantec has been handling the SCADA review. They are to have a report to Operations within the month.

A question was raised regarding expiry dates to Crossing Agreements. Mr. Minchin advised the Commission that all crossing agreements put in place are perpetuity.

MOVED by Mayor Poole to accept reports as information.

Administrator Report

Mr. Minchin presented the Administrator's report.

In summary:

- Administration is in the process of transitioning Administrators on a temporary base.
- Administration has not received the 2018 water rates from the City of Red Deer. The
 City of Red Deer is in agreement to have the water rates to the Commission by
 November 1st of the current year. The Administrator will remind Red Deer of their
 commitment to the Commission
- The 5-year projection has been updated based on the current information provided to the Commission.

- Water sales remain to exceed 2017-budgeted amount. Water sales in the summer were high.

2018 Operating Budget Update

Mr. Minchin shared a copy of the provisionary budget that was presented at the September 25, 2017 meeting based on an expected 5% increase from the City of Red Deer from \$1.38 to \$1.45. Based on this information Administration recommends that the water rate for the Commission be set at \$2.07 from \$2.03. The Commission has not had a rate increase since 2013. Should the 2018 water rate from Red Deer not increase by the expected 5%, Administration recommends leaving the Commission's rate at \$2.07.

Concerns of why there was a need for a SCADA review and the costs for the upgrade was expressed. Mr. Minchin advised the Commission that the systems is outdated and not supported anymore in areas, and the cost of the upgrade will be covered from capital reserves.

It was asked how often Administration reviews the rate model that Red Deer uses to set their rate. Mr. Minchin explained that the model is 190 pages and is reviewed every couple of years. Red Deer uses a cost recovery utility rate model.

MOVED by Councillor Matejka to accept reports as information.



The following is a summary of items Administration has been working on since the Board's last meeting:

- 1. Administration received the 2018 water rate from the City of Red Deer. As a result the budget is being presented for adoption. This item appears later on in the agenda.
- 2. Administration will be updating the 5 year projection for the Board's information based on the current information provided to the Commission. This includes the actual City of Red Deer rate increase for 2018.
- 3. Administration met with the City of Red Deer to further discussions on the sale of a portion of the water line. Further meetings will be held in the new year

2018 Operating Budget

The North Red Deer River Water Services Commission transports potable water from the City of Red Deer to its member municipalities. Currently, the Commission delivers water to all its members. The 2018 budget forecasts revenues based on the water demand estimates provided by the member municipalities. The largest costs to the Commission are the purchase of water from the City of Red Deer and debenture payments.

The following is a summary of changes included in the 2018 operating budget followed by the budget itself.

Water Costs

The 2018 operating budget is based on a 6.5% increase in water rates from the City of Red Deer. The rate from the City of Red Deer has increased from \$1.38 to \$1.47 per cubic metre effective March 1st, 2018. The Commission is received a formal letter from the City at the end of November. The details of the rate and impact on the budget are outlined on page 3.

Water Sales Volumes

Water sales volumes for 2018 have been increased slightly from the estimates from the 2017 budget. Actual consumption for 2017 was slightly lower than forecasted and Administration is forecasting slower growth in the coming years. Included in the estimate is a change to the water loss estimate. Water forecasts are outlined in page 4 of this document.

Other Operating Revenues and Expenditures

In addition to water purchases and sales volume estimate adjustments, Administration has also reviewed all expenses for the Commission and made a number of adjustments. The following is a summary of those adjustments. The operating budget starts on page 5.

Revenues

- 1. Adjust revenue from City of Red Deer to reflect projected water volumes and delivery charges. Cost of water is not charged to the Commission and therefore a lower rate is passed on to the City for Central Park. This change results in a reduction in revenue estimate of \$29,850. An offsetting charge to water costs to the Commission has also been made.
- 2. Increase in line crossing fees of \$500 to reflect growing income.
- 3. Increase of \$6,489 in interest revenue to reflect growing cash balances.

Expenses

- 4. Increase in Board travel and mileage of \$250 to reflect change in Board membership.
- 5. Increase of \$100 in Administration travel to cover miscellaneous travel, if required.
- 6. Increase in \$300 in Volunteer recognition for retiring board members in 2018.
- 7. Increase in Telephone Office of \$680 to replace phone.
- 8. Increase of Management Fees based on a January 1st increase. A \$1,116 increase.
- Decrease in Other Professional Services of \$30,000 to recognize completion of SCADA review.
- 10. Increase in Equipment Maintenance costs of \$2,000 to reflect ongoing maintenance costs.
- 11. Increase in SCADA costs to reflect monthly rate increase. Annual increase of \$725.

- 12. Increase Administration (accounting services) based on a January 1st increase of \$204.
- 13. Water purchases are based on projected water volumes and the new City of Red Deer rate.
- 14. Increase in Operations costs to reflect increased rates effective January 1st from \$121,300 to \$123,637 (\$2,337 increase).
- 15. No Change in electricity costs to factor in additional carbon tax increases in 2018.
- 16. Amortization remains unchanged. As this is a non-cash expense, the reserve policy will see this transferred to capital reserves at the end of the year in 2018.
- 17. Funding from rate stabilization reserve of \$215,000 to offset rate increase from City as per 5 year plan.
- 18. The operating surplus has been reduced to make up the increase in water rates from the City. The projected operating surplus has been reduced from 125,000 to 117,213 a reduction of \$7,787. The Commission will still access \$215,000 from the stabilization reserve.
- 19. There are no operating costs yet associated with the SCADA project. Capital installation is expected in 2018 with additional costs possible in mid 2018. The Commission's final draft would include this costs within the proposed rate increase.

Water Rates

Based on the 6.5% increase from the City of Red Deer, Administration is proposing a rate of increase of 1.97% effective March 1, 2018. The rate would increase for the first time since 2013 from \$2.03 to \$2.07 per cubic metre. This rate increase from the City of Red Deer was higher then anticipated (5%) but commission's rates could be maintained at \$2.07 per cube with a reduction in the operating surplus from \$117,213 to \$69,404 as a result.

2018 Capital Budget

The only proposed project for 2018 is the SCADA project. An initial estimate of \$200,000 is proposed funded from the Commission's Capital Reserves. The final estimate will be presented at the November Board meeting along with possible operating cost implications.

2018 Water Supply Rates

We have recently evaluated our water financial and rate allocation models and have tentatively established rates for 2018, subject to Council approval. Please be advised that the unit rate for the supply of water under the Water Supply Agreement with the North Red Deer River Water Services Commission (NRDRWSC) is expected to increase to \$1.47 per cubic metre, effective March 1, 2018.

The NRDRWSC rate was calculated on a cost of service basis, utilizing the principles set out in the American Water Works Association manuals of practice. The price was derived using an estimated volume of 2,812,263 cubic metres, which is a 0.3% increase over the forecast 2017 volume of 2,804,145. The 2018 rate is an increase of 6.5% above the 2017 rate of \$1.38 per cubic metre.

As per the Water Supply Agreement, we will prepare a "true-up" reconciliation following our 2018 year-end to develop an actual cost per cubic metre based on actual costs and supply volumes. We will then issue an invoice or credit if the actual unit cost is more than 10% above or below that used during the course of the year.
