#### 5. Reports

Chair Christie introduced the City of Lacombe's new CAO, Dion Pollard. Mr. Pollard comes to the City from the Town of Vermilion. He has been with the City of Lacombe now for 6 week and comes with regional waterline knowledge and experience. The Town of Vermillion became active on a regional system in 2012.

#### In summary:

- The Alberta One-Call locate requests have slowed from previous quarter, although they are in line with 2016's numbers
- Operations responded to call outs regarding communication lost at 39th Avenue due to dead batteries. Communication was lost at the main vault; Operation just had to reset the modem.
- Working with Red Deer to get the connection to Central Park. The City of Red Deer has had to flush the line due to sediment and leaks. The water meter is installed at the meter chamber and is operational.
- SCADA Assessment RFP is completed. Recommendation will be present to the Commission for consideration.

#### Administrator Report

Mr. Minchin presented the Administrator's report.

#### In summary:

- Water Meter has been installed and water is being delivered to the City of Red Deer. So far 8,000 cubic meters has been delivered, budgeted for 20,000.
- The Commission has received approval from the Province to sell water to the Commission
- Trying to meet with Red Deer to determine the impact of a sale of a portion of the line will have on rates.
- The necessary crossing agreements are in place with the Regional Wastewater Commission. They will be working very close to the water line during construction.

Mr. Minchin presented the financial report.

#### In summary:

- Both revenue and expenses are in line with budget expectations.
- The SCADA Assessment costs are under Other Professional Services in the 2017 Operating Budget

The Chair shared that he has received a call from a consultant regarding the announcement from the Government to provide funding to First Nations to access safe water. The same information is included in Correspondence to the Board.

#### Bylaw 3.1 - Amend Water Rate Bylaw #3

Mr. Minchin presented Bylaw #3.1, a bylaw to amend the current Water Rate Bylaw #3 to include the rate of \$1.899 per cubic meter for the sale of water to Red Deer based on the sales of 20,000 cubic meters. The rate calculation has been based on the utility rate method in the Commission's Water Rate Model. The water rate to the Commission will remain the same at \$2.03 per cubic meter.

#### SCADA Review RFP - Tender Award

Mr. Huston shared that the current communication system is obsolete, can still get parts but not sure for how long. A communication monitoring system lifecycle is usually 5 to 6 year. The Commission's system is 13 years old.

A request for proposal was issued to study the requirements of the System and provide recommendations to the Commission. Five companies showed interest and were present for a tour of the City of Red Deer site to see how the new system on the regional line will need to be incorporated with Red Deer's system.

Upon review and scoring of the RFP's received, there were two submissions that had the highest scoring proposals, Eramosa and Stantec. Administration recommends

that the Commission go with Stantec based on their existing knowledge of the Commission's current system, and their proposal will look at a variety of systems.



- ➤ <u>June 23</u> Red Deer noticed flow issues at the main vault again, operator scheduled Summit valve to perform maintenance on the Singer valve June 28.
- June 28 Operator and Summit at the main vault performing maintenance on the Singer valve.
- ➤ <u>July 6</u> Operator changed PLC battery at the Red Deer Treatment Plant, and then met Red Deer operators at the main vault to troubleshoot pressure variances experienced since Summit Valve was there.
- ▶ <u>July 7</u> Operator, Summit Valve and 2 Red Deer operators at the main vault to verify and modify pressure/flow from the main vault.

#### Call-Out:

- ➤ <u>June 20</u> Red Deer Treatment Plant called operator at 8:00pm –Storm hit Red Deer knocking out power and affecting flows through the main vault to the regional line; 2 operators worked with Red Deer to restore flows.
- August 10 Operator called at 7:30 pm by Red Deer No communication with Railway - operator reset modem and restored communication.

Attached is the 2017 variance report as of August 31th for the regional water commission.

The Commission set a record for water sales in July while August sales were more in line with historical averages. The summer consumption helped offset lower consumption earlier in the year. Water sales to the City of Red Deer have dropped as their customers adjust to new water rates. Projections to the end of the year anticipate water sales being slightly ahead of budget.

Expenses remain in line with expectations. No extraordinary expenses have been incurred.

The projected surplus to the end of the year is currently at \$61,300 compared to a budgeted surplus of \$70,579.

#### **PURPOSE:**

To consider a request from the City of Lacombe and Lacombe County to allow for the transit of Lacombe County water supply via the City of Lacombe connection to the regional water line and to ensure the delivered water is counted towards the County's water allocation with the Commission.

#### BACKGROUND:

At their August 24th and August 28th meetings, Lacombe County Council and City of Lacombe Council agreed to enter into agreements whereby the City of Lacombe would supply lands in Lacombe County West of Highway 2 with water and wastewater services.

In the case of water, the water supplied to the County lands will flow through the City's water distribution system from a water supply provided by the Commission.

The Commission tracks water supplied to its members from meters located at each member municipality's water reservoir. The water supplied to the City is based on allocations allotted to each member under the Commission's Bylaw #1 and the supply agreement between the City and the Commission dated October 17, 2005. The County also has water allocation based on the same Commission Bylaw #1 and a water supply agreement between the Commission and the County dated September 13, 2005. The County currently does not have any direct connections to the regional water line.

To ensure that the County water supplied by the City is applied against the County's allocation with the Commission, an agreement between the three parties is necessary.

#### ISSUE ANALYSIS:

The proposed memorandum of agreement between the City, County and Water Commission will ensure that the water supplied to the lands west of highway 2 and located in the County are applied to the County's water supply allocation. Without this agreement the allocation would be counted at the Commission's point of delivery, which

in this case is the City of Lacombe. The agreement is similar to agreement already entered into between the Town of Blackfalds, Lacombe County and the Water Commission for lands located west of highway 2 and supplied by the Town of Blackfalds.

Highlights of the agreement include:

- 1. The City will be responsible to the Commission for the purchase and payment of all water used.
- 2. The City will provide, on annual basis, actual consumption consumed for the area as well as future forecasts.
- 3. Should the area be annexed by the City, the water will then come from the City allocation.
- 4. This reallocation is not to be considered the County's connection to the regional line and the County will be required to maintain its annual administration and debt servicing cost funding to the Commission.
- 5. The Commission will provide no funding towards the construction of these services as there is no direct connection to the regional line itself.

#### FINANCIAL IMPLICATIONS:

No cost to the Commission. The City will be responsible for paying the cost of any water delivered by the Commission.

#### **LEGISLATIVE AUTHORITY**:

- North Red River Water Services Commission Bylaw #1.
- North Red River Water Services Commission and City of Lacombe Water Supply Agreement dated October 17, 2005.
- North Red River Water Services Commission and Lacombe County Water Supply Agreement dated September 13, 2005.

#### **SERVICE LEVEL IMPACT:**

 No impact on service levels as there is no new direct connection to the regional line.

#### NORTH RED DEER RIVER WATER SERVICES COMMISSION

(herein referred to as the "Commission")

#### OF THE FIRST PART

-AND-

#### CITY OF LACOMBE

(herein referred to as the "City")

#### OF THE SECOND PART

-AND-

#### LACOMBE COUNTY

(herein referred to as the "County")

#### OF THE THIRD PART

The County intends to construct water lines (herein called the "water lines") connecting lands (herein referred to as the "Lands" and described in Schedule "A" attached hereto and forming part of this agreement) located in the County to the City's water distribution system; and

The Lands are the same lands identified by the City and County in its Joint Economic Servicing Agreement, dated June 5, 2017, and Ownership of the said water lines will be vested with the County, and

The City and County have proposed to supply the Lands through a connection to the City's water distribution system, and

The City and County are members of the North Red Deer River Water Services Commission and both have entered into separate Water Supply Agreements with the Commission, and

The County currently receives water from the Town of Blackfalds through a similar memorandum of dated December 8, 2014, and

The Commission sells Water to the City through connections (herein called to the "Points of Delivery") between the Commission's regional line and the City's distribution system and therefore,

In consideration of the terms and conditions specified in this document the parties agree as follows:

#### 1. The Commission agrees that:

- a. It will sell potable water to the City in order to supply the Lands.
- b. It will ensure that water is supplied to the City's points of delivery in accordance with the terms of the Water Supply Agreement between the Commission and the City, dated October 17, 2005.
- c. It will apply the same rate established by the Commission for the supply of water to its Member to the supply of water to the Lands.
- d. The supply of water to the Lands will not constitute as one of the connections as identified in Schedule "D" of the Water Supply Agreement between the Commission and County and dated September 13, 2005.
- e. The supply of water to the Lands shall be applied against the water allocation for the County as defined in the Water Supply Agreement with the County.

#### 2. The City agrees that:

- a. It will purchase all water to be supplied to the Lands from the Commission.
- b. It will be responsible for payment to the Commission for the sale of all Commission supplied water to the Lands that is supplied through the City's distribution system.
- c. It will provide, on annual basis, the actual consumption consumed by the Lands as well as a five year forecast no later than September 30<sup>th</sup>.
- d. The City shall notify the Commission when the City begins to supply water to the Lands.

#### 3. The County agrees that:

- a. It will not resell water delivered to the Lands for the purpose of the supply of water to a confined feeding operation or for injection into any geological subsurface structure or formation.
- b. It will continue to pay the minimum payment to the Commission as outlined in section 2 of Schedule "E" of Water Supply Agreement between the Commission and the County and dated September 13, 2005, unless otherwise negotiated between the County and the Commission.
- c. The water supplied to the Lands will be applied against the water allocation identified in the Water Supply Agreement between the Commission and the County.

#### 4. The parties agree that:

- Costs incurred for the construction of the water lines, including but not limited to, the construction of a water meter chamber shall be the sole responsibility of the County and/or the City.
- Responsibility for the operation and maintenance of the water line and any meter chamber at the point of service to the Lands shall be the responsibility of the County and/or City.
- c. This Memorandum of Agreement will be revisited by the parties in the event that the County receives a request to service properties outside of the area identified as the Lands.
- d. Should the Lands be annexed by the City, this agreement will terminate at time the annexation takes effect and the supply of water will be applied against the

City's water allocation from the Commission as identified in the Water Supply Agreement between the City and Commission.

- 5. The terms of the Water Supply Agreements and the Commission's Bylaw 1 shall apply to any matters not addressed in this MOA. Where provisions of this Agreement conflicts with the terms of the Commission's Bylaw 1 and or the Water Supply Agreements, the Commission's Bylaw 1 and the Water Supply Agreements shall take precedent.
- 6. The City shall indemnify and hold harmless the Commission, its employees and agents from any and all claims, demands, actions and costs or whatever may arise, directly or indirectly, or indirectly, out of any act or omission of the City, their employees or agents, in the performance by the City of this Agreement. Such indemnification shall survive termination of this agreement.
- 7. The County shall indemnify and hold harmless the Commission, its employees and agents from any and all claims, demands, actions and costs or whatever may arise, directly or indirectly, or indirectly, out of any act or omission of the County, their employees or agents, in the performance by the County of this Agreement. Such indemnification shall survive termination of this agreement.
- 8. The parties agree to give this Agreement a fair and liberal interpretation and to negotiate with fairness and candor, any modification or alteration that may be rendered necessary by changing conditions.
- 9. This Agreement will expire on September 9, 2030, unless extended by mutual agreement of all parties.



#### 2018 Operating Budget

The North Red Deer River Water Services Commission transports potable water from the City of Red Deer to its member municipalities. Currently, the Commission delivers water to all its members. The 2018 budget forecasts revenues based on the water demand estimates provided by the member municipalities. The largest costs to the Commission are the purchase of water from the City of Red Deer and debenture payments.

The following is a summary of changes included in the 2018 operating budget followed by the budget itself.

#### Water Costs

The 2018 operating budget is based on a 5% increase in water rates from the City of Red Deer. The projected rate from the City of Red Deer is expected to increase from \$1.38 to \$1.45 per cubic metre effective March 1<sup>st</sup>, 2018. The Commission is waiting a formal estimate from the City which is expected in October. The details of the rate and impact on the budget are outlined on page 3.

#### Water Sales Volumes

Water sales volumes for 2018 have been increased slightly from the estimates from the 2017 budget. Actual consumption for 2017 was slightly lower than forecasted and Administration is forecasting slower growth in the coming years. Included in the estimate is a change to the water loss estimate. Water forecasts are outlined in page 4 of this document.

#### Other Operating Revenues and Expenditures

In addition to water purchases and sales volume estimate adjustments, Administration has also reviewed all expenses for the Commission and made a number of adjustments. The following is a summary of those adjustments. The operating budget starts on page 5.

#### Revenues

- 1. Adjust revenue from City of Red Deer to reflect projected water volumes and delivery charges. Cost of water is not charged to the Commission and therefore a lower rate is passed on to the City for Central Park. This change results in a reduction in revenue estimate of \$29,850. An offsetting charge to water costs to the Commission has also been made.
- 2. Increase in line crossing fees of \$500 to reflect growing income.
- 3. Increase of \$6,489 in interest revenue to reflect growing cash balances.

#### **Expenses**

- 4. Increase in Board travel and mileage of \$250 to reflect change in Board membership.
- 5. Increase of \$100 in Administration travel to cover miscellaneous travel, if required.
- 6. Increase in \$300 in Volunteer recognition for retiring board members in 2018.
- 7. Increase in Telephone Office of \$680 to replace phone.
- 8. Increase of Management Fees based on a January 1<sup>st</sup> increase. A \$1,116 increase.
- 9. Decrease in Other Professional Services of \$30,000 to recognize completion of SCADA review.
- 10. Increase in Equipment Maintenance costs of \$2,000 to reflect ongoing maintenance costs.

- 11. Increase in SCADA costs to reflect monthly rate increase. Annual increase of \$725.
- 12. Increase Administration (accounting services) based on a January 1st increase of \$204.
- 13. Water purchases are based on projected water volumes and the new City of Red Deer rate.
- 14. Increase in Operations costs to reflect increased rates effective January 1<sup>st</sup> from \$121,300 to \$123,637 (\$2,337 increase).
- 15. No Change in electricity costs to factor in additional carbon tax increases in 2018.
- 16. Amortization remains unchanged. As this is a non-cash expense, the reserve policy will see this transferred to capital reserves at the end of the year in 2018.
- 17. Funding from rate stabilization reserve of \$215,000 to offset rate increase from City as per 5 year plan.
- 18. The operating surplus has been reduced to make up the increase in water rates from the City. The projected operating surplus has been reduced from 125,000 to 117,213 a reduction of \$7,787. The Commission will still access \$215,000 from the stabilization reserve.
- 19. There are no operating costs yet associated with the SCADA project. Capital installation is expected in 2018 with additional costs possible in mid 2018. The Commission's final draft would include this costs within the proposed rate increase.

#### Water Rates

Based on the projected 5% increase from the City of Red Deer, Administration is proposing a rate of increase of 1.97% effective March 1, 2018. The rate would increase for the first time since 2013 from \$2.03 to \$2.07 per cubic metre. This rate increase could be adjusted lower based on final City of Red Deer water rate and possible SCADA operating costs.

#### 2018 Capital Budget

The only proposed project for 2018 is the SCADA project. An initial estimate of \$200,000 is proposed funded from the Commission's Capital Reserves. The final estimate will be presented at the November Board meeting along with possible operating cost implications.

#### **PURPOSE:**

To appoint an acting chair to deal with emergencies and act as a signing authority until the permanent appointments of Chair and Vice Chair are made at the November 6, 2017 Board meeting.

#### BACKGROUND:

With the retirement of both the Board Chair and Vice Chair in October, the Commission will be without an authorized signing member until the November 6, 2017 meeting.

In addition, two additional Board members will be seeking reelection via an election. Only one Board member, Mark Matejka has been acclaimed. To ensure continuity, Administration is recommending that Mark Matejka be appointed Acting Chair effective October 23, 2017 until Board elections which be held on November 6, 2017.

#### **ISSUE ANALYSIS:**

Administration has put forth this recommendation for two reasons:

- 1. To ensure that there is a recognized elected head of the Commission during the transition.
- 2. To ensure that there is an elected representative with signing authority available should the need arise to issue cheque payments during this transition period.

Administration is taking steps to ensure that as many payments are made prior to Election Day. The appointment of an acting chair is a preventative measure only and member Mateika would only be called upon in an emergency situation.
