#### 1. Call to Order:

Chair Creasey called the meeting to order at 9:00 am.

#### 2. Adoption of the Regular Meeting Agenda

#### 4. Presentations

#### 4.1. 2022 Financial Audit – BDO Canada LLP

Mr. Levia and Mr. Wachter of BDO Canada LLP, reviewed the Auditor's Report and the 2022 Audited Financial Statements, comprising of the financial position as of December 31, 2022. The non-financial assets book value is \$26.6 million cost less amortization, surplus of 26.5 million. Long-term debt payments for 2023 will be \$880,000. Debt limit has \$3.8 million remaining debt capacity. Statement of Operations was close to budgeted amounts. Water sales revenue was under budget, Purchase of water expense was under budget. Interest income was well above budgeted amount due to rising interest rates on investments. The amortization of capital assets process was discussed.

#### 5. Reports

#### 5.1. Administrator

CAO Thompson presented the Administration Report highlighting the Board of Directors second orientation session June 19th. Effective March 1, City of Red Deer water consumption rate will be \$1.64 per cubic meter. Due to higher than predicted rates, NRDRWSC will require a modest rate increase to members starting in 2024. A draft Memorandum of Understanding with Ermineskin Cree Nation (ECN) and NRDRWSC has been delivered to the province. The Commission has requested the province approve access to grant funds to cover management and legal costs to date.

Financials were provided for January/February. Water volumes are slightly higher than 2022 and expenses slightly lower than budgeted.

Operations and the City of Red Deer will perform Regional Reservoir Refresh for all nine facilities over the course of the year.

#### 5.2 <u>Chair</u>

Chair Creasey provided a verbal report of his communication with a representative from another First Nations community regarding the waterline expansion to the north and the interest from other First Nations in the area to potentially become a member in the future.

#### FINANCIAL


As seen in Table 1, overall, 2023 water volumes for January to April are higher by 5.57% than the actual 2022 levels for the same period.

#### <u>Revenue</u>


As of April, YTD (year to date) actual revenues are lower than YTD budgeted revenues by \$139,246 or 6.88%. This variation is typical for the colder months of the year and the variation will change during summer months as increased water usage occurs.

#### **Expenses**

As of April, the YTD actual expenses are lower than YTD budgeted expenses by \$62,887 or 3.74%. Water purchases from the City of Red Deer are under budget for the first 4 months of 2023 by \$102k. The variance for water purchased is expected to diminish as more water is used in the summer months. Unbudgeted legal fees of \$33k have occurred relating to the water system expansion expected to be offset by grant revenue.




#### Surplus/Deficit

As of April 2023, the Water Commission has a YTD net deficit of approximately \$76K, of which \$33k relates to unbudgeted Legal Fees for the water system expansion.

#### Notable activities since last report:

- Regional Reservoir refresh for all the facilities. Planning is underway in Lacombe to use specified volumes to move a large amount of water and calibrate the water meters using a "draw down test."
- Developing and using a Weed Maintenance Control Plan at the regional facilities, including the vaults. The plan is being made in consultation with the City of Lacombe's Parks Supervisor.

#### **Upcoming Activities:**

• Meet with member operators to discuss the regional system and their respective operations. Outline future meetings, and brainstorm shared training opportunities amongst the group.
